- To be eligible for an incentive, I understand that the dwelling must be a new residential premise constructed in the FortisBC service area or in one of the following electric utilities: Grand Forks, Kelowna, Penticton, Summerland or Nelson Hydro. I understand that the dwelling must have a primary electric space heating system (ie: air source heat pump, ground source heat pump, electric forced air, electric baseboard) to be eligible for the insulation, domestic hot water and EnerGuide Rating rebates.
- I understand that the occupancy permit must have been issued on or after January 1, 2011, to be eligible for the PowerSense New Home rebates. I understand that products covered by this program must be purchased and installed after Jan 1, 2011 and before Jan 1, 2012 to be confirmed by sales receipts.
- I understand that I must supply FortisBC with copies of the clear, legible sales receipt and/or invoice summary that clearly indicate make, model, and any other required information about the product purchase in order to allow confirmation that the product purchase meets program criteria. I understand that all products installed in the home must meet qualifications defined by FortisBC. ENERGY STAR® labelled products must be listed on the NRCAN website: <http://www.energystar.gc.ca>.
- I understand that I am solely responsible for full payment of the contract with the Contractor. FortisBC Inc. will have no obligation to pay the amount of the grant to the Homeowner if the contract has not been completely performed, or pay out to the Homeowner any greater amount than the amount of the grant herein agreed.
