# EnerChoice® Fireplace Program

## Terms and conditions

### Overview

FortisBC customers (each, a “Customer”) that purchase a qualifying natural gas fireplace between June 1, 2011 and May 31, 2012 may be eligible for a \$300 rebate. FortisBC is offering an additional rebate of \$50 to the dealer involved with the purchase of the Customer’s fireplace (each, a “Dealer”).

### Eligible homes

In order for the Customer and Dealer to qualify for a rebate under this program, the Customer must be a current residential customer of FortisBC Energy Inc., FortisBC Energy (Vancouver Island) Inc. or FortisBC Energy Inc. (Whistler) (collectively, “FortisBC”) and the Dealer must install the fireplace in a residence in the Lower Mainland, Whistler, Squamish, Fraser Valley, Interior of B.C., Vancouver Island or the Sunshine Coast.

The Customer/Dealer is eligible to apply for one rebate for each qualifying EnerChoice fireplace purchased and installed. Please ensure that proof of purchase for each qualifying EnerChoice fireplace is obtained from the Dealer at the time of purchase.

### Eligible fireplaces

To qualify for the rebate, the fireplace must be:

- an EnerChoice rated free-standing stove (66% FE or higher), fireplace (62.4% FE or higher) or insert (61% FE and higher).
- purchased between June 1, 2011 and May 31, 2012.
- installed in accordance with the requirements of the BC Safety Authority and/or gas authority having jurisdiction in your area and in accordance with the manufacturer’s specifications and all applicable laws, codes, standards and ordinances.

### Program process

- To be eligible for a rebate, the applicant must return a copy of the completed application form with a copy of the purchase invoice for the fireplace and a copy of the gas contractor invoice that contains the date of installation, details of the work performed and the registration number of the gas fitter and installation permit number.
- If an applicant is applying for more than one rebate, the applicant must ensure that each fireplace is clearly documented on both the purchase invoice and the gas contractor invoice. Customers must fill out an individual application form for each \$300 rebate requested.
- Applications must be postmarked no later than June 30, 2012.
- Applications must be signed by the applicant.
- Processing of applications may take a minimum of 90 days.
- FortisBC is not responsible for lost, delayed, damaged, illegible or incomplete applications.
- FortisBC reserves the right to refuse applications that it determines, in its sole discretion, are incomplete, inaccurate or otherwise do not meet program requirements.

### Rebates

- Rebates will be issued by cheque for each qualifying fireplace
- Dealer rebates will be issued to the business name identified on the application form.

### Representations and warranties

- Both the Customer and the Dealer acknowledge the program eligibility criteria and warrants that he/she/it fully qualifies.
- The Customer and the Dealer warrant that all the information contained in the application and the information attached thereto is true and correct.

### Additional terms and conditions

- FortisBC may amend, modify or terminate this program at any time based on funding limitations or for any other reason, without notice.
- FortisBC, not being the designer, manufacturer or provider of fireplaces, makes no representation or warranty, express or implied, as to the necessity, quality or efficiency of any fireplace submitted under this program and accepts no liability or responsibility for such fireplaces.
- FortisBC accepts no liability for work performed by or on behalf of a Customer with respect to the purchase, installation or maintenance of a fireplace in conjunction with this program.
- The Customer agrees that FortisBC may record any resulting reductions in emissions and credit them to the FortisBC Greenhouse Gas Management Program.
- The Customer agrees that FortisBC has no liability concerning any estimated energy savings of fireplaces submitted under this program or the installation, performance or fitness of such fireplaces.
- The Customer and the Dealer are solely responsible for any tax liability imposed as a result of receiving a rebate cheque.
- This program is independent of other incentives and rebates by FortisBC and/or other utilities, manufacturers, or government incentive programs or grants.
- Rebates cannot be assigned or transferred to another recipient.
- By applying for this rebate offer, the Customer and the Dealer acknowledges and agrees that FortisBC (or one of its agents):
